### **Regional Context of Noxious Weed and Pest Animal Management**

To assist Local Government Victoria in gaining an understanding of the regional perspective, briefly provide a summary of noxious weeds and pest animal management on council managed roadsides in your municipality.

Murrindindi Shire is situated on Melbourne's peri-urban fringe. The Shire spans 3,887 square kilometres of which 48% is Crown land. With the exception of a small area south of Kinglake, most of the shire lies in the upper part of the Goulburn River Catchment.

Predominately rural, including large production farms down to smaller hobby farms, the terrain ranges from mountainous to steep hills, rolling hills and river flats. Murrindindi Shire benefits from great natural beauty and tourist attractions such as Lake Eildon, picturesque national parks, the Great Victorian Rail Trail and access to Victoria's snowfields.

Murrindindi Shire Council (MSC) is responsible for the management of approximately 1,218 km of local road network. There are several main roads managed by Vic Roads that traverse the Shire. MSC proactively targets weeds on roadsides and unused road reserves in partnership with other ties of government, agency and community groups. MSC regularly liaises with various land management agencies and works collaboratively with the Upper Goulburn Landcare Network. MSC works with its partners to promote and encourage landholders across Murrindindi to undertake responsibilities under the *Catchment and Land Protection Act 1994*.

Council understands the importance of partnering with community volunteers. These partnerships give Council access to local expertise and knowledge and help to produce better results on ground. This Plan and Program has been developed with this in mind - focusing on ways in which Council and other tiers of government can work with individual landholders and community groups to support and expand on existing work happening across the Shire.

MSC is dedicated to managing weed infestations on council managed land and committed to the early prevention and control of weed species newly identified in the area.

Through past State Government funding (FY16-17) initiatives Council has treated approximately 810 km of roadsides for Regionally Controlled Weeds and established pest animals. Refer to Table 1 for a list of current target species. State Government funding has assisted MSC to contribute to collaborative programs with other public land management agencies, and grassroots movements such as Landcare and Blackberry Action Groups.





### **Community Consultation**

The Murrindindi Shire Council Environment Officer stays in close touch with community concerns via attendance at meetings of Landcare or other groups and via phone calls and correspondence from individuals. The Shire has also specifically requested community views on this issue via the 'Have Your Say' survey and maintains a record of feedback. Much of the information required to develop this plan had already been obtained during development of the proposed Murrindindi Shire Environment Strategy, previous Roadside Pest & Weed Control Plan 2015-2017 and liaison with relevant community groups. DEDJTR Compliance programs have been considered when developing the plan.

The recent 'Have Your Say' community survey conducted by the new council indicated that respondents considered the natural environment one of the main reasons for the love of the shire. Weed control enforcement on private landholders and absentee landholders was raised as was blackberry control on road reserves (no specific roads mentioned). There is an expectation from the community that local government will undertake weed control on council managed land.

Council actively liaises with the Upper Goulburn Landcare Network (14 groups) and Landcare groups individually. Council's Environment Officer sits on a number of committees including Blackberry Action Groups and the recently formed King Parrot Fox Control Groups.

Murrindindi Shire Council collaborates with the Hughes Creek Catchment Collaborative (an umbrella group administering the finances and coordinating the activities of 4 Landcare groups, mostly in the neighbouring Shire of Strathbogie) on weed control in the Highlands and other parishes on/or near the Shire boundary.

Council's Environment Officer receives numerous calls from the public seeking information on weed control and these conversations shape the public interests. Customer requests include control of Paterson's Curse, Blackberry, Chilean Needle Grass, Cape Weed and numerous environmental weeds.

## **Objectives of the Plan**

Murrindindi Shire Council's overall roadside weed and rabbit management objective is the effective and proactive management of invasive species on Council managed roadsides across the Shire. Investment of funds will be aligned to:

- 1. Treatment for the eradication of Regionally Prohibited Weed infestations.
- Treatment for the containment or reduction in area of infestations of Regionally Controlled Weeds and rabbits – aligned to DEDJTR weed and rabbit compliance project area.
- 3. Supporting community group investment in declared weed and pest control projects.
- 4. Contributing to other previous investment in the control of Regionally Controlled and Regionally Prohibited Weeds and rabbits.
- 5. Protect identified assets such as significant roadside vegetation under threat from weed invasion or other significant roadside infrastructure, or nearby natural assets.
- 6. Support weed and pest animal management programs being undertaken by land owners.
- Addressing other roadside declared noxious weed infestations of concern to the Shire's community including Restricted Weeds declared under the Catchment and Land Protection Act 1994 (CaLP Act), such as Chilean Needle Grass.

## Term of the Plan
