# Please take your rubbish with you

Murrindindi Shire Council, the Department Of Environment Land Water and Planning (DELWP) and Parks Victoria welcome visitors to enjoy the beautiful parks and forests in Murrindindi Shire.

When visiting, we do ask that you please respect the local environment by taking a 'carry in, carry out' approach to your rubbish.

You can do this by planning ahead for your visit and making the necessary preparations to either take your rubbish home with you or dispose of it at one of the Resource Recovery Centres (RRCs) listed on the back of this flyer.

Prices for disposing of rubbish at the RRCs start from \$1 for a small bag and \$2 for a large bag.

### **DO:**

- Bring rubbish bags to collect your waste
- Take your rubbish home with you
- Check the opening times and visit a local transfer station

### **DON'T:**

- Dump your rubbish in the bush
- Burn rubbish in a campfire
- Use private residence or local business bins to dump your waste

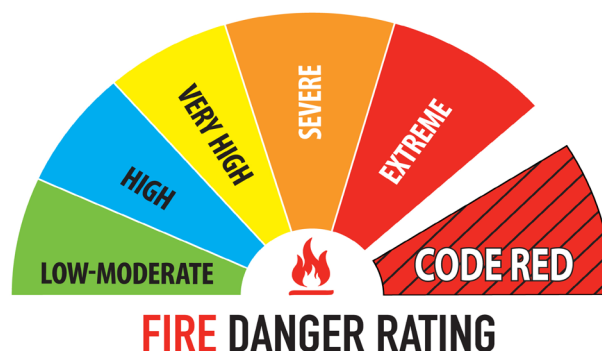
**FIRE DANGER RATINGS AND TOTAL FIRE BAN DAY**

**Total Fire Bans** are legal restrictions on open fires, equipment and BBQs that prevent fires from starting. Campfires, bonfires or any kind of outdoor fires are strictly banned on a **Total Fire Ban** day, for more information about what can and can't do on **Total Fire Ban** days see [www.cfa.vic.gov.au/can](http://www.cfa.vic.gov.au/can).

**Total Fire Bans** are declared by the CFA on days when fires are likely to spread rapidly and could be difficult to control.

**Total Fire Bans** can be declared at any time, they are separate from **Fire Danger Ratings**.

**Fire Danger Ratings** are put in place for each region depending on the local conditions. Murrindindi Shire is in the **North Central Fire District**. Ratings help you to know when the local conditions are dangerous enough to enact your bushfire plan. That might mean leaving the area early, well before there are any signs of fire – once a fire has started, the chances are it will be too late to leave.



Visitors to parks and forests should expect them to be closed on 'Code Red' days. Code Red days are rare but when they are forecast, they are extremely serious.

It is up to you to find out what the Fire Danger Rating is in your area and to act accordingly. Ask your neighbouring camp if you don't know.
