Managing Vegetation on Your Property: The 10/30 and 10/50 rules and fence line clearing

The Victoria Planning Provisions regarding vegetation removal have changed as a result of recommendations made by the Victorian Bushfire Royal Commission.

Bushfire Management Overlay

This is a land management overlay on land which is of high bushfire risk. It will ensure that bushfire issues are fully considered in any new developments within this overlay and it can have an impact on the siting of a building, providing defendable space, on-site water availability and emergency vehicle access. If risk to life and property from bushfire cannot be reduced to an acceptable level the development will not be approved.

Vegetation and bushfire

Removal of vegetation is only one way to reduce bushfire risk. You should have a good understanding of the risks at your property and also have a comprehensive bushfire survival plan.

Finding the balance

We encourage residents to think carefully about tree and vegetation removal and to contact our Planning Unit on (03) 5772 0317 or planning@murrindindi.vic.gov.au to check if you need a permit.

When considering the removal of trees and vegetation, please think about their value. Are they fire retardant varieties? Do they provide shading or screening? What will replace them and will their removal cause problems with land slip or erosion? Also, research has shown that fine fuels such as long dry grass, dry leaves and twigs add to fire intensity so it is important to manage those hazards at all times.

Vegetation removal around buildings built or approved after 10 September 2009

Vegetation removal around buildings built or approved before 10 September 2009

If there is no Bushfire Management Overlay on the property the 10/30 rule applies and you do not need a planning permit to clear:

- any vegetation, including trees, within 10 metres of your house*
- any vegetation, except for trees, within 30 metres of your house*

If there is a Bushfire Management Overlay on the property the 10/50 rule applies and you do not need a planning permit to clear:

- any vegetation, including trees, within 10 metres of your house*
- any vegetation, except for trees, within 50 metres of your house*

Check your property title to ensure that there are no covenants or other legal agreements which may conflict with the above rules. If you're not sure please contact us on (03) 5772 0317.

Clearing along boundary fences

You can also clear any vegetation for a combined maximum width of 4 metres across existing boundary fences. You need to obtain permission from the landholder to clear vegetation on land which does not belong to you.

Permission is required from Council or VicRoads where the vegetation is on a road reserve. If unsure please contact our Planning Unit on (03) 5772 0317 or planning@murrindindi.vic.gov.au.
