

# **Swimming Pool or Spa Registration**

Building Regulations 2018 - Regulation 147P (1) - Form 22

The Victorian Government requires all swimming pools and spas in Victoria to be registered, inspected and certified on a regular basis.

Property owners in Murrindindi Shire are responsible for registering their pools and spas with Murrindindi Shire Council, arranging for inspections of safety barriers and correcting any non-compliance issues reported through the inspection process.
