KINGLAKE COMMUNITY EXERCISE

Council is working with Emergency Management Victoria to run an emergency management exercise in Kinglake in March. The purpose of the exercise is to help everyone, community and emergency services, be better prepared, and understand the complex needs and challenges that may arise, in the event of an emergency

As part of the exercise, Council and emergency services will operate a mock relief centre at the Kinglake Community Centre on Saturday 25 March between 10.00 am – 3.00 pm.

Locals are invited to register to participate in the exercise and will be provided with a scripted persona (character) to act out on the day, which will reflect real challenges and opportunities for emergency services to respond to. You do not need experience or specific knowledge to be involved.




REGISTERED PETS ARE SAFE PETS

Do you own a dog or a cat? If your pet is registered with Council, you will soon receive your 2023-2024 pet registration renewal notice, with a due date of 9 April.

Nearly one quarter of Murrindindi Shire residents own a dog or a cat, and keeping your beloved pet safe is important. That's why it's a legal requirement for all cats and dogs over the age of three months to be registered with Council, under the *Domestic Animal Act 1994*. These requirements help us reunite you with your beloved pet, should they become lost.

QUEENSLAND FRUIT FLY AND BLACKBERRY A destructive love story

It is time to keep your eye out for Queensland Fruit Fly (QFF), an incredibly destructive pest that targets ripening summer fruit and fruiting vegetables. QFF becomes more active in warmer weather and adult female flies lay their eggs within a wide range of host fruits.

If left uncontrolled QFF can not only lead to damaged produce for backyard fruit and vegie growers, but it can cause total crop loss for our farmers.

Blackberry can be a vector for QFF movement, enhancing the spread of this insidious pest.

Most municipal roadsides contain some Blackberry. Council's seasonal Roadside Weed Control Program focuses on Blackberry and other noxious weeds and is almost complete.

Working on a landscape level, together with your neighbours, to control Blackberry and the spread of QFF will deliver the best outcome.

PROJECT DELIVERY UPDATES

Blue Gums to Eildon Recreational Trail

Construction of the Blue Gums to Eildon Recreational Trail is about half-way complete!

Once we finish excavation works and establish a solid base for the trail, we'll apply a spray seal to trail and carry out landscaping works. We are busy completing other important elements of the project including gabion basket stone retaining walls as part of an extension of the trail to the Eildon Pondage weir, and the construction of a pit stop area at the front of the Big4 Breeze Holiday Park - Eildon (Blue Gums Caravan Park).

People will soon be able to walk or ride the trail and enjoy views of the Goulburn River and the Eildon Pondage. We expect to complete the project in mid April. The trail will link the popular caravan park with the Eildon Township and encourage greater use of Eildon's parks, playgrounds, facilities and businesses.

Thanks to Regional Development Victoria for funding of \$1.77 million to supplement Council's \$190.000 investment to deliver this exciting project.

Drainage upgrades on Kinglake-Glenburn Road

During the first half of 2023, Council will deliver kerb upgrades and carry out underground drainage works to alleviate existing drainage issues on Kinglake-Glenburn Road, on the southern side between the Kinglake Service Station and Elm Grove, Kinglake.

Gravel Roads Re-sheeting Program

Council will soon commence its Gravel Roads Resheeting Program. Re-sheeting involves grading and re-shaping gravel roads, reshaping of table drains, and the application of a layer of new gravel over the existing gravel road surface.

We will re-sheet over 27 km of gravel roads across the Shire from March and until May 2023 including:

- Clarkes Road, Thornton
- Forest Road, Flowerdale
- Horns Lane, Fawcett
- Killingworth West Road, Killingworth
- Larritts Lane, Glenburn
- Limestone Road, Limestone
- Shannons Road, Limestone
- Swamp Creek Road, Taggerty
- Thoms Lane, Thornton

Any disruptions for residents will be kept to a minimum.

New Skate and Play Spaces for Alexandra

It is wonderful to see the community enjoying the new playground and skate park in Alexandra, which is nearing completion. Gates and water play features will be installed over the coming weeks, as well as the minor defects attended to, and the pump track is in the final stages of construction. Further landscaping and planting of more vegetation should see this project fully completed over the next couple of months, weather depending.

We have had wonderful feedback from the community and due to this, Council is considering the installation of further seating, bins and fencing. Consideration is also being given to upgrading the original flat sections in the skate park and possibly replacing and repairing of the older more cracked concrete, to ensure the precinct can be the best it can be for everyone to enjoy well into the future.

This \$1.725 million project has been possible due to the support from Sport and Recreation Victoria and Regional Development Victoria.

Council intends to host an official opening soon and will be back in touch with the community with more information about this event.

Eildon Reserves Redevelopment

Members of a Deliberative Panel in Eildon are participating in an independently run, collaborative engagement process relating to the proposed sale of Council-owned parcels of land, to part fund the Eildon Reserves Redevelopment Project.

The Panel sessions are focusing on:

- the Project, including how it was originally identified as a need for Eildon and its benefits to the community and local economy
- the sale of land, including the benefits of selling underutilised land and the trade-offs
- the housing shortage in Eildon
- recommendations to Council on the way forward for the Project

A final report on the recommendations from the community is being prepared by the panel members supported by Capire Consulting Group, which Council engaged to facilitate this deliberative process. The report will be presented to Council and it will guide the decision on the way forward for the Project, including a decision on the sale of land parcels.

MEET SCOTT, ONE OF OUR COMMUNITY SAFETY OFFICERS

Scott works as a Community Safety Officer at Council. We asked Scott a few questions, so you could find out a bit more about them and their role.

Can you tell us a bit about your professional background?

I have been in Local Government for over 20 years, starting at Nillumbik Shire Council as a Machinery Operator. I was then given a great opportunity to study and train to become a Ranger, working at Nillumbik for 10 years, before moving over to City of Whittlesea, where I spent 10 years as a Local Laws and Fire Prevention Officer. I spent two years as an Acting Team Leader of the Local Laws Unit before taking up my role as Community Safety Officer at Murrindindi Shire Council in June last year.

What do you enjoy most about your role?

Being a member of my local CFA for over 30 years, I have a particular passion for fire prevention awareness and education and enjoy being able to contribute to Murrindindi Shire's fire preparedness activities. The work I've most enjoyed is coordinating Council's Roadside Slashing Program, together with our Parks and Gardens Team, and rolling out our Fire Prevention Program, which involved promoting a community awareness campaign and helping community members keep their properties safe and well-prepared for bushfires and grassfires.

What does a typical day working in your role look like?

There really is no typical day working in Community Safety – there is a lot of variety in the work we do. Some days I might be helping reunite a lost dog with its owner, working with the local Police on educational campaigns, or simply talking with locals and listening to their concerns. I like to spend time with community and find ways I can support them through my role at Council.

What do you love most about Murrindindi Shire?

The staff. The area. I can happily say I have the best office! My view every day when I drive around would make a great screen saver. Our team is a close team, and we are all there for each other if one of us has a bad day. I did ten years at Nillumbik, ten at Whittlesea, so I think the tradition of ten years will stay true for Murrindindi.
