### Murrindindi Shire Flood Statistics August 2023

Accurate information on the October 2022 floods in terms of the number of impacted properties, the cost of damage to assets and loss of business revenue is not readily available. Certainly, the data which is available does not provide an holistic picture of the cost or extent of the damage caused by the floods. The data is fragmented as it was collected for specific purposes by individual agencies. It is unlikely that an accurate picture will ever be available.

Emergency Recovery Victoria (ERV) reports that as of August 2023, one household from Murrindindi Shire remains in temporary accommodation, from the cohort of individuals who were uninsured and opted into the ERV Temporary Accommodation program. But that is only one part of the housing equation. We do not have access to data about flood impacted households who are living in temporary accommodation, funded through their insurance.

Accurate figures are available for property owners, particularly farmers, who experienced damage and sought assistance from government. However, those whose properties were damaged but were subsequently repaired without seeking assistance are not recorded in any of our figures. Anecdotally we know that there were many farmers who did not seek grant assistance for a variety of reasons.

178 people have so far made contact or been referred for the State case management service.

## **Status of Work Packages to Reinstate Damaged Assets**

There are 5 road-based packages currently being finalised., These are made up of 14 location-based aggregations of work.

Additional packages will be prepared for bridge repair, major culvert works and minor culvert works. These will be allocated to packages according to the significance (size) of the identified works.

In addition, there are 13 locations which have suffered landslips as the result of flooding. These are currently under investigation; and will be fully assessed when the relevant geotechnical reports are received.

The five road-based packages will be undertaken under the Immediate Work DRFA category, due for completion by 31 December 2023. Streamlined processes for DoT approval and Council acceptance of quotes for packages need to be in place to meet the tight timelines.

Preparation of documentation for road-based packages is underway, in parallel with the DoT approval process.

Road-based package One, approval to undertake works, has been submitted to DoT with the corresponding supporting information.
